- Dr. Tippett asked if there was a way to contact every student, grades 8-12, throughout the county and about reaching the home-schooled community. Dr. McCabe responded that she was unsure about contacting every student and would have to find the best means to do that: she added that we have reached out to the home school co-op community.
- Dr Tippett congratulated a job well done with the Senior Symposium and Graduation. "Very nicely done! We may have to find another venue for the next graduating class of 2025!"
